IADC, OOC to receive OTC award for deepwater well control guide

IN OUR INDUSTRY, doing the right thing is a way of life. When it comes to providing for the safety of our employees, safeguarding the environment and protecting our assets, drillers are second to none in stepping up to the plate.

Sometimes someone even notices!

Last week, the Offshore Technology Conference announced it would present a Special Citation to IADC and the Offshore Operators Committee for developing the IADC/OOC Deepwater Well Control Guidelines.

The award will be presented at the 2004 OTC Awards Luncheon on 4 May in Houston.

"In naming you recipient of a Special Citation, the OTC Awards Committee and the OTC Board cited your foresight, initiative and leadership in the development of the guidelines," wrote OTC Chairman Roderick J Allan in a letter to IADC President Dr Lee Hunt.

The landmark guidelines represented a concerted, industry-led effort in which drilling contractors, oil-producing firms, oilfield service companies, academics and government officials worked side by side

IADC and OOC formed the Deepwater Well Control Task Force in 1997 to identify critical well-control issues as the industry moved into the deepwater frontier. On top of that, the task force determined to complete its work within one year—hardly a leisurely time table!

The 54 volunteers who participated represented 36 IADC and OOC member companies, as well as government and academia. They are shining examples of our industry's tradition of stepping up to the plate on the tough problems. Their generosity, and that of their organizations, in providing time and talent cannot be overstated. I'd like to cite **Diamond Offshore**

Drilling Inc in particular, for contributing a whopping 10 people to the effort.

The task force was chaired by Moe Plaisance, Vice President-Operations Support, Diamond Offshore Drilling, Inc.

The original guidelines, published in 1998, cover well planning, well control procedures, equipment, emergency response and training. In 2000, at the request of MMS, the task force was reassembled to produce a special supplement dealing with preventing unplanned riser disconnects on floating rigs.

The IADC/OOC Deepwater Well Control Guidelines are often cited as an example of industry-government cooperation in ensuring safety and environmental protection offshore. In 1999, IADC received a commendation from the US Coast Guard, US Minerals Management Service and the National Research Council that specifically cited the IADC/OOC Deepwater Well Control Guidelines.
