

Santa Fe's Garber is elected 2002 IADC Chairman

IADC'S LEADERSHIP FOR 2002 has a deep appreciation of the challenges facing drilling contractors and their operator and service/supply partners in the year ahead. And the new officers have the broad range of experience necessary to meet those challenges.

At the 2001 IADC Annual Meeting, 25-28 Sept in New Orleans, the Board of Directors elected **C Stedman Garber Jr.**, President and Chief Executive Officer of Dallas-based **Santa Fe International Corp.**, to serve as the Association's 2002 Chairman.

The board elected **Lawrence R Dickerson** to the position of Vice Chairman, and **Marion M**

Woolie was chosen 2002 IADC Secretary-Treasurer. Mr Dickerson is President and Chief Operating Officer of **Diamond Offshore Drilling Inc.**, with headquarters in Houston. Mr Woolie is President of **Global Marine Drilling Co.**, also based in Houston.

The IADC Board also elected 3 Divisional Vice Presidents and 5 Regional Vice Presidents.

In addition, IADC President **Dr Lee Hunt** and Senior Vice President-Government Affairs **Brian T Petty** were reelected. All terms are effective on 1 January, 2002.

C STEDMAN GARBER JR

Mr Garber is only the fourth person to serve as President of Santa Fe since the company was founded in 1946. He was named President in 1995 and became CEO in 1998.

Mr Garber joined Santa Fe in 1984 as Vice President of Planning and Acquisitions, and in 1989 was appointed President of **Santa Fe Minerals Inc.** In 1991 he was named Executive Vice President and CEO of Santa Fe International.

Before joining Santa Fe, Mr Garber served with **Getty Oil Co** from 1977 to

1984. From 1972 until 1977, he was Vice President of Corporate Finance for **Blyth Eastman Dillon & Co.**

A native of Cincinnati, Mr Garber received a BS degree in engineering from the **US Naval Academy** in 1965. While attending Annapolis, Mr Garber and his crew won two National Intercollegiate Rowing Association championships. After 5 years of naval service, including duty in Vietnam, Mr Garber earned an MBA in finance from the **University of California at Los Angeles** in 1972.

A Director of IADC, Mr Garber served during 2001 as IADC Vice Chairman and during 2000 as the IADC Secretary-Treasurer. He is past Chairman of IADC subsidiary Drilling Contractor Publications Inc, publisher of IADC's official magazine *Drilling Contractor* and the *Annual IADC Membership Directory*. He is a past member of the IADC Executive Committee.

LAWRENCE R DICKERSON

Prior to being promoted to his current position in March 1998, Mr Dickerson held the position of Senior Vice President and Chief Financial Officer for the previous 6 years. He joined **Diamond Offshore** in late 1979 and has held various management and financial positions with the firm.

After receiving a bachelor of business administration degree with honors from the **University of Texas** in 1976, Mr Dickerson worked at the Houston office of the public accounting firm of **Ernst & Young LLP**, specializing in the broadcast and energy industries. He became a Certified Public Accountant in 1978.

From 1972-1974, he served in the **US Army**. Mr Dickerson, a Director of IADC, served during 2001 as IADC Secretary-Treasurer. He is also a director of the **National Ocean Industries Association**, as well as a member of its Executive Committee. He is a member of the **Ocean Research Advisory Panel**, a governmental committee assigned the task of reporting on environmental and technological issues.

MARION M WOOLIE

Mr Woolie began his career with **Global Marine** in 1982 as a Senior Sales and Contracts Representative of **Global Marine Drilling Co.** He was promoted to Vice President Sales, North & South America in 1985 and Senior Vice President-Sales & Contracts in 1997.

He assumed his current position in May 1998. Prior to joining **Global Marine** he worked from 1973 to 1982 for **National Supply Co.**, where he held various position within the wellhead/subsea and drilling equipment divisions.

An IADC Director, Mr Woolie served during 2000 as the IADC Vice President-Offshore Division and sat on the Association's policy-making Executive Committee during 1999-2001. He is also a member of the **American Petroleum Institute**.

Mr Woolie holds a bachelor's degree in management and an MBA degree in finance from **University of Houston**.

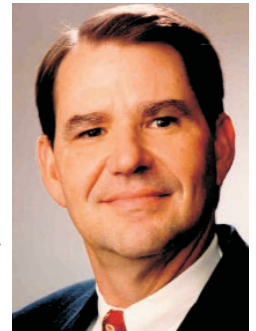
DR LEE HUNT

BRIAN T PETTY

IADC Senior Vice President-Government Affairs Petty is based in Washington with global responsibilities. Mr Petty joined IADC in 1983 as Manager of Government Affairs. A native of Texas, Mr Petty holds a law degree from **Georgetown University** and an MA in literature from the **University of Virginia**.

Prior to joining IADC, he served in Washington as the State of Texas Energy Counsel. He previously practiced law with the New York firm of **Mudge Rose Guthrie & Alexander**, then headed up the Houston office of the international investment banking firm **Warburg Paribas Becker**.

MEMBERSHIP GROWTH

From small to large, on land and offshore, IADC member firms serve every region around the world.

A robust market increased membership in 2001, with the number of internation-

al members up 50% (those firms with headquarters outside the US and Europe). Total IADC membership increased 8% to 912 companies; the number of contractor members increased 15% to 264 firms.

A new North Africa Chapter, based in Cairo, was formed in 2001 and a Caspian Chapter, based in Baku, was recently inaugurated. ■
