## IADC Board of Directors elects 2007 officers

AT THE 2006 Annual Meeting held on 21-22 September in San Antonio, Texas, the IADC Board elected **Transocean Inc's Robert L Long** as the association's 2007 chairman. Mr Long is CEO and a member of the Board of Directors of Transocean.

IADC's Board also elected **John Lindsay** as vice chairman. Mr Lindsay is executive vice president, US and international operations, for **Helmerich & Payne International Drilling Co.** **Mark A Jackson** was elected secretary-treasurer. Mr Jackson is president and chief operating officer of **Noble Corp.**

**Dr Lee Hunt**, IADC president, and **Brian T Petty**, IADC senior vice president-government affairs, were re-elected. **David Russell**, vice president of drilling for **Rowan Companies**, was elected vice president of IADC's Land Division. **Claus V Hemmingsen**, executive vice president of **AP Møller-Maersk Group**, was elected vice president of IADC's Offshore Division. **Darrell Johnson**, vice president-drilling for **Seven Energy LLC**, was elected vice president of IADC's Drilling Services Division.

### ROBERT L LONG



Robert L Long is chief executive officer and a member of the Board of

Directors of Transocean Inc. Mr Long served in various executive-level positions before being named to his current position in October 2002. He was elected vice president in 1987, senior vice president in 1990, senior vice president and CFO in 1996, senior vice president, treasurer and CFO in 1997, executive vice president, treasurer and CFO in 2000, president in 2001 and president and chief operating officer in 2002.

Mr Long joined the company in 1975 as corporate planning manager and has held numerous operational and financial roles, including division engineer and division manager of the North Sea and Egypt. A 1968 graduate of the US Naval Academy, Mr Long attended the US Naval Nuclear Power School and in 1975 earned an M.B.A. in finance from the Harvard Graduate School of Business.

### JOHN LINDSAY



John Lindsay is executive vice president-US and international operations for Helmerich & Payne IDC. He assumed his current position in March 2006. Prior to this appointment, Mr Lindsay had served since 1997 as H&P vice president-US land operations. Mr Lindsay joined H&P in 1987. He has since worked as roughneck and driller; drilling engi-

neer; operations manager in Oklahoma City for the company's mid-continent region; and division manager for all of the company's US land rigs.

Mr Lindsay graduated in 1986 from the University of Tulsa, where he earned a Bachelor of Science degree in petroleum engineering.

### MARK A JACKSON



Mark A Jackson was named president and chief operating officer of Noble Corp effective 10 February 2006. Mr Jackson served as senior vice president and chief operating officer of Noble from 1 March 2005 to 9 February 2006. He served as senior vice president and chief financial officer, treasurer and controller of Noble from 1 September 2000 through 26 September 2005.

From May 1999 to August 2000, Mr Jackson served as executive vice president and chief financial officer for **Santa Fe Snyder Corp.** From August 1997 to May 1999, he served as senior vice president and chief financial officer of **Snyder Oil Corp.**

Prior to August 1997, Mr Jackson served consecutively in the positions of vice president and controller, vice president-finance and vice president and chief financial officer of **Apache Corp** beginning in 1988.

Dr Lee Hunt serves as the chief executive of IADC, responsible for managing IADC's worldwide operations. Before being named president in 1990, his prior Association positions included manager for state government affairs, environmental affairs and human resources. Mr Russell is currently responsible for offshore and land drilling operations worldwide.

## CLAUS V HEMMINGSEN



Claus V Hemmingsen is executive vice president of AP Møller-Maersk Group and has been a member of its

Executive Board since July 2006. He began with AP Møller-Maersk in 1981, spending most of his early career in its Offshore Contract Drilling Division, named **Maersk Drilling**.
